SUBJECT: Policy Change - IMSA New Jersey Section Certification

DATE: March 9, 2017

EFFECTIVE DATE: April 1st 2017

IMSA New Jersey Section has adopted a new policy pertaining to all Certification Courses offered by our Governing body the International Municipal Signal Association.

Effective on April 1st 2017 The New Jersey section will no longer order Manuals for our scheduled certification classes.

The person seeking Certification will have to purchase their Course Manual from the IMSA National Office.

The reasoning behind this change in policy is we have read the surveys and an overwhelming majority requested that they would like the Manual in advance of attending our Certification Classes. We have heard your concerns and we have enacted the change on how we will conduct our Certification classes as we move forward.

All the Officers of the New Jersey Section unanimously agree with your request to have manuals before the class is held.

We pledge to advertise all certification courses at a minimum of four months in advance of the class or classes start date. This change will also reflect a lowering of our cost for certification classes, please visit our web site for current pricing. One other important item will be is you must have a manual to attend the class no exceptions.

As a side benefit from this change in policy we will have at a minimum two certification locations in a calendar year. One will be held in New Jersey and one in Pennsylvania so you can plan ahead and prepare for the certification class, At this time our current locations will be Bordentown, New Jersey (early spring) and Harrisburg, Pennsylvania (August).
